## Premier Community Credit Union Electronic Document Disclosure

- By viewing this document, you have access to computer/software to view our electronic documents that we provide to you, such as this document.
- By explicitly submitting a request (either in writing, in e-mail or through electronic signup) for electronic documents, i.e. e-statements, notices, etc., you have given affirmative consent to Premier Community Credit Union to provide documents in electronic format for each category of documents.
- By accepting electronic documents, you have an option to withdraw such request at any time in writing, e-mail, or electronic cancellation request without any fees. However, this fee is subject to change with 30 day notice.
- By accepting each category of electronic documents separately, i.e. e-statements, notices, loan documents, and other membership correspondences, you will not be automatically signed up other electronic document deliveries. You must explicitly consent to receive electronic documents for each category of documents.
- By accepting electronic documents, it is your responsibility to ensure Premier Community Credit Union has your most current e-mail address. You must notify us in writing, in e-mail, or through electronic update of any changes to your e-mail address.
- By accepting electronic documents, you have an option to request paper copy of electronic records with proper fee according to our fee schedule.
